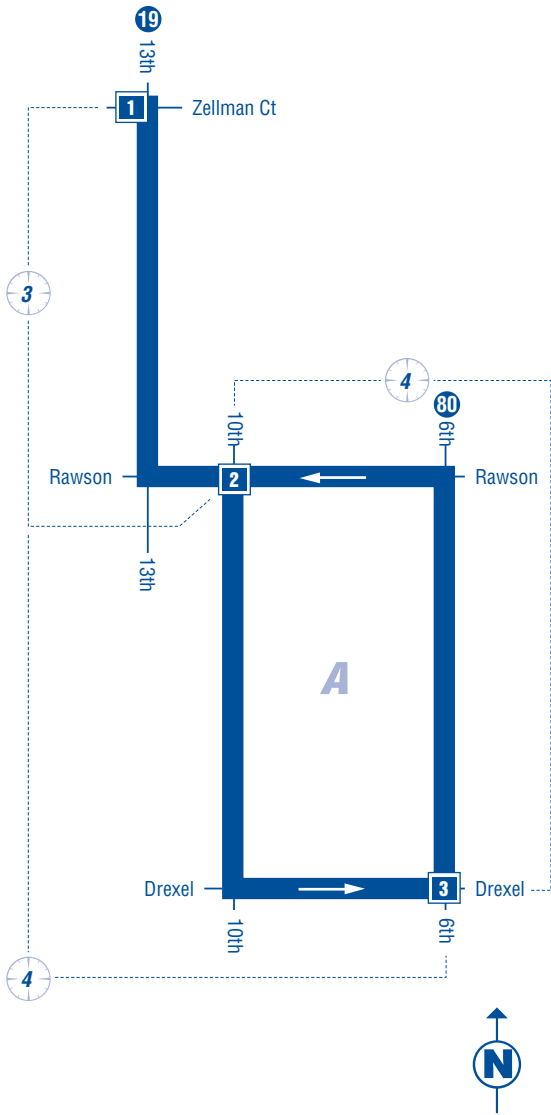

**Making a Title VI Complaint**
