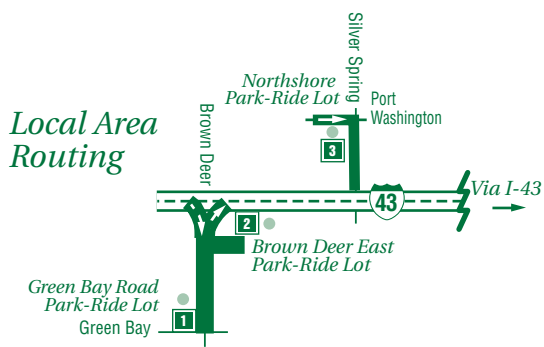
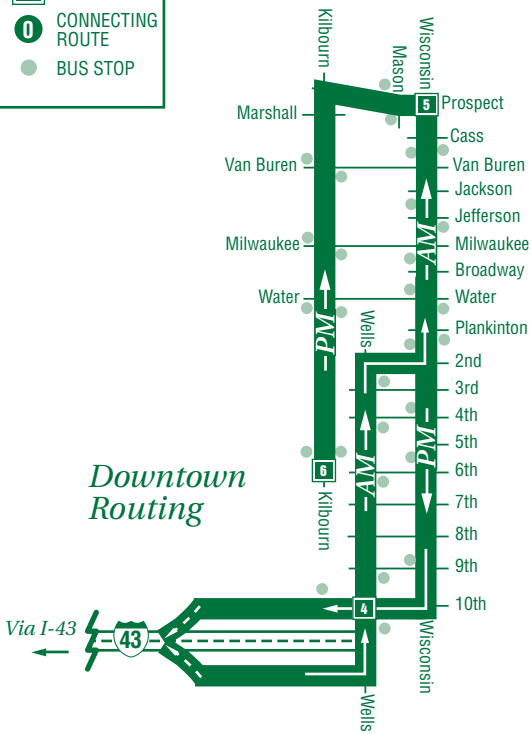

Making a Title VI Complaint
