

HOW TO USE THIS ROUTE GUIDE

- Open the schedule and locate the direction of travel and day of the week you wish to travel. Find the intersection closest to where you want to catch the bus.
- 2 Look down the column of this intersection and timepoint for your departure time for that stop. Regular print means AM times and bold print means PM times.
- 3 Read horizontally along the line that lists your departure time to determine when you will arrive at your destiantion.
- To plan your return trip, look at the reverse direction of travel on your schedule and follow these same steps. Please note that on most routes, the stop for your return trip will be located across the street from the stop where you boarded the bus.
- When you see a bus approaching, look at the electronic destination sign above the front windshield to verify the route number and final destination match those given in your route guide.

Making a Title VI Complaint
